8 Having been served with notice of this comprehensive adjudication pursuant to Code of Civil
9 Procedure sections 835 and 836 and with notice of the Court's February 5, 2026, Order Requiring Filing
10 of Answer and Phase 3 Form Discovery (**February 5 Order**), and pursuant to the requirement codified
11 by Code of Civil Procedure section 836(k) that "it shall be the duty of all claimants interested in the
12 proceedings and having notice of the proceedings pursuant to this chapter to appear in the proceedings
13 and to submit proof of their claims," the Court adjudges and determines that:

14 Those individuals and entities appearing on Exhibit 1 who failed to file an answer, and those
15 individuals and entities appearing on Exhibit 2 who failed to submit Phase 3 Form Discovery as
16 required by the February 5 Order, have failed to appear and prove their claim pursuant to Code of Civil
17 Procedure section 836(k). Accordingly, the correlative share of the Basin water supply adjudicated to
18 the overlying rights holders appearing on Exhibits 1 and 2 is hereby reduced to zero and subordinated
19 to those correlative rights holders who have appeared in this adjudication and are presently using the
20 available supply.
